A. General


B. Purpose of EoI

The Smart City Thiruvananthapuram Limited (SCTL) intends to have a web & mobile-based Project Management Software to handle the entire life-cycle of the project from the Administrative sanction till the closure of the contract. - MIS reporting (alerts on slippage of schedule, physical progress, financial progress, CPM/PERT, various charts & reports, etc.)
- Measurement Module - Daily Measurements, Combined Measurement (milestone based/ group based / etc.)
- Financial Progress Monitoring and Fund utilization

The brief functionality requirements are given in Annexure 1. The firm can add additional modules and functionalities to meet the entire requirement of Project Management Software.

Note: The entire work has to be completed and the software shall be operational within 2 months from the date of Letter of Award.

The SCTL will arrange a technical presentation based on the EoI submitted and the schedule and venue for conducting the presentation will be intimated later. The real data (one of the ongoing projects) will be shared with the firm to demonstrate the functionalities.
