- Technical & Price Bid also shall be submitted through online mode only.
- Details regarding remittance of Bid Submission Fee and Bid Security, Bid preparation and submission are mentioned in the bid document.
- The bids shall be opened at the office of the SCTL in the presence of the authorised representatives of the Bidders, who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.
- Tenders/ bids received without the details mentioned in Instructions to the Bidders will not be considered and shall be summarily rejected.
