**Category of Vehicle: Toyota Etios/ Maruti Swift Dzire/ Tata Tigor/ Honda Amaze - Compact Sedan car (full option vehicle with A/C). (The Tax, insurance and all other compliances should be updated)-3 nos**

The first registration of the vehicle should be on or after **01.01.2018**. Fresh vehicles will also be considered, subject to the condition that the new vehicle must be provided within 10 days, failing which it gets disqualified.

The hire charges should be quoted in monthly rate inclusive of all applicable taxes and charges. All applicable taxes, duties and levies lawfully payable by the operator shall be included in the contract price (shall be shown separately). TDS shall be deducted from the Operator's bill/payment as per the provisions of Government rules. The contractor should provide the drivers wages, fuel and maintenance of the vehicle. The quoted vehicle must be a fuel drawn vehicle and the hire may be quoted with fuel charges. Rates may be quoted for the first 1500 km per month, which will be fixed and based on this Prebid will be evaluated and selection of lowest bid shall be made. For additional plying beyond 1500 km per month, rate has to be mentioned for every km per month. Rates for additional time may also be quoted. The awarded rate shall be firm & will remain in force for the entire period of Contract. No demand for revision of rate on any account shall be entertained during the contract period. In case of breakdown of the service, the operator shall provide a relief vehicle of the same capacity, to continue the onward journey. The vehicle must be available for service whenever SCTL demands, even on holidays. On usual working days, vehicles should be available in the office from 9.30am till 6.30pm and also must be available as and when required on call basis (24x7) (Additional charge of Rs.50/- per hour (as over time batta) will be provided). A penalty of daily cost shall be imposed and deducted from the running bills of the operator, in case alternate vehicle isn't provided. The Company reserves the right to terminate the contract either in part or in full. In such an event, the Company shall give 30 days notice in writing to the operator of its decision to do so. Operator, upon receipt of such notice, shall discontinue the work after the notice period.
